

LEADING THE NEW WAVE OF DEEP TECH INNOVATION





PROCEDIN – PROCUREMENT CAPABILITY FOR EMBEDDING AND DRIVING **INNOVATION**

The PROCEDIN project aims to accelerate Procurement of Innovation (POI) in the context of European cities' innovation for sustainability and resilience agendas, focusing on circular economy and green mobility. The consortium will leverage existing resources and its members' extensive, pan-European professional networks, and initiate new provisions, to enhance and mobilise POI motivation, knowledge and skills. The project is a cooperation between the municipalities of Haarlem (NL) and Grabovo (BG), start-up platform F6S (IRE), educator the University of Twente (NL), and platform provider and project supporter Pedal (SK).

BUILD – BUILDING CAPACITIES IN INNOVATION PROCUREMENT FOR CITIES

The BUILD project aims to achieve three main objectives to steer innovation procurement in Europe. Particularly, it will first encourage cooperation and knowledge sharing between public buyers for sustainable innovation via the creation of a platform. The project will also discover the most up-todate innovative technological solutions and assist in their development and further acquisition from buyers. To achieve this, it will facilitate the enhancement of innovation knowledge and skills to establish synergies with EU-funded research and innovation projects focusing on Public Procurement for Innovation. Private procurers, SMEs and start-ups will be engaged and trained. The project team consists of partners from Slovakia, Estonia, Finland and the Netherlands.



INNOFACILITATOR - THE EUROPEAN FACILITATOR COMMUNITY PROMOTING **PUBLIC PROCUREMENT OF INNOVATION IN HEALTHCARE**

The InnoFacilitator project aims to create a community by leveraging capabilities and promoting innovation procurement within healthcare. More specifically, it provides support, tailor-made training and coaching services. The objective is to increase the awareness, skills and knowledge about innovation procurement among the buyers and the solution providers (including SMEs and startups). The project will also foster a community supported by online collaborative tools and encourage the co-design of innovation procurement (by matching the buyers' needs for research and development and helping them to identify existing innovative solutions). The project team consists of partners from Spain, Italy, Belgium and France.
